(PARKING AVAILABLE ALL AROUND THE BUILDING)

From South Jersey Rt. 295

Take 295 to Exit 61A Arena Drive East. Exit onto Arena Drive. Go to 3rd traffic light, Whitehorse Rd, turn left. Go one block to next traffic light and bear right onto Whitehorse-Hamilton Sq. Rd. Go past two traffic lights. The second light is Cypress Lane. Turn left at second driveway after Cypress Lane. The first driveway is a new assisted living facility. **The Coalition Office is a large black & gray office building, 1670 Whitehorse-Hamilton Sq. Rd. Our office is on the first floor, left, and front and can be accessed from the left side of the building or front and back doors in the middle of the building.**

From NJ Turnpike North or South

Take Exit 7A, 195 West to exit 3B Hamilton Sq. Exit onto Yardville-Hamilton Sq. Rd. Go to 1st traffic light, Kuser Road; turn left at Yardville National Bank Building. Stay on Kuser Rd. to next traffic light and turn right onto Whitehorse-Hamilton Sq. Rd. Go past next traffic light at Cypress Lane. Follow above directions after Cypress Lane.

From NJ East Shore Points

Take Garden State Parkway to 195 West. Follow above directions.

From NJ South Shore Points - Several Alternatives

- ◆ Take Garden State Parkway to Atlantic City Expressway to Rt. 206 North. Take 206 toward Trenton. Watch for signs for 195 east. Follow above directions from Exit 3B Hamilton Sq.
- ◆ Take Garden State Parkway North to 195 West. Follow directions above to office.
- ◆ Take Atlantic City Expressway to 295N. Follow above directions.

From North Jersey - Western Counties

HUNTERDON AND WARREN

- ◆ Take 31 South to I-95 North. I-195 North merges with 295 and becomes 295 South. Get off at Exit 63, Route 33 West to Trenton. Go to first traffic light, Klockner Rd. and turn left. Stay on Klockner Rd. to third traffic light. Robert Wood Johnson Hospital is at this intersection. Turn right onto Whitehorse-Hamilton Square Rd. Travel 4/10ths of a mile. The Coalition Office is on the right. The driveway is past the 1670 building sign. See above directions for building access and parking.

SUSSEX COUNTY

- ◆ Take 206 South all the way through Princeton to 295 South to Exit 63. Follow above directions.

MORRIS COUNTY – Three alternatives

- ◆ Take 206 South to 295, Exit 63. Follow above directions.
- ◆ Take I-287 South to 206 south to 295 south, Exit 63 and follow above directions.
- ◆ Take I-287 South to NJ Turnpike, South to Exit 7A and follow above Turnpike directions.
